VI. Approval of Endorsement of NAMI Montgomery County PA for Reaffiliation

Ms. Ference reviewed the Education Report highlighting the upcoming children's conference. Maria Kakay reviewed the Communications and Marketing report highlighting the children's conference and NKPA's role in assisting NAMI with a national photo and video shoot that took place in Pittsburgh in October.

IX. Other News/Business

Board Member Cherie Brummans announced the Alliance of Community Service Providers DSP Conference is taking place virtually on Thursday, November 19, 2020. The event is free and open to everyone. Board member Neen Davis announced that NAMI Montgomery County PA's annual Benefit for the Brain is taking place virtually on Nov. 18. There is no cost to participate. This year's event includes a 30-minute program and 30 minutes to chat with the awardees.
